14 \$200.20.

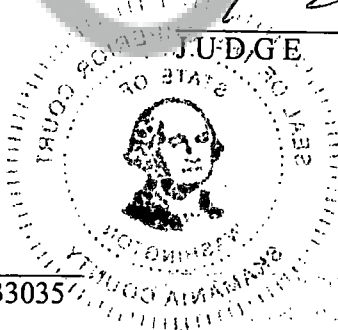

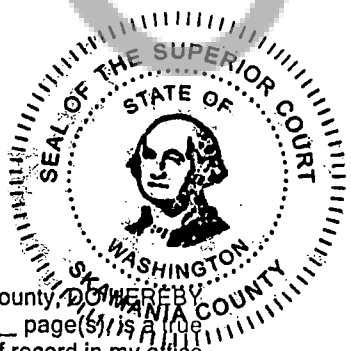
