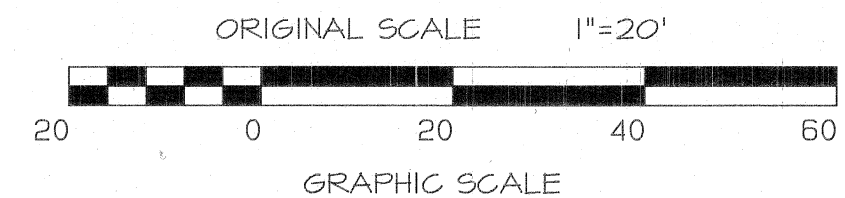

SURVEY NARRATIVE

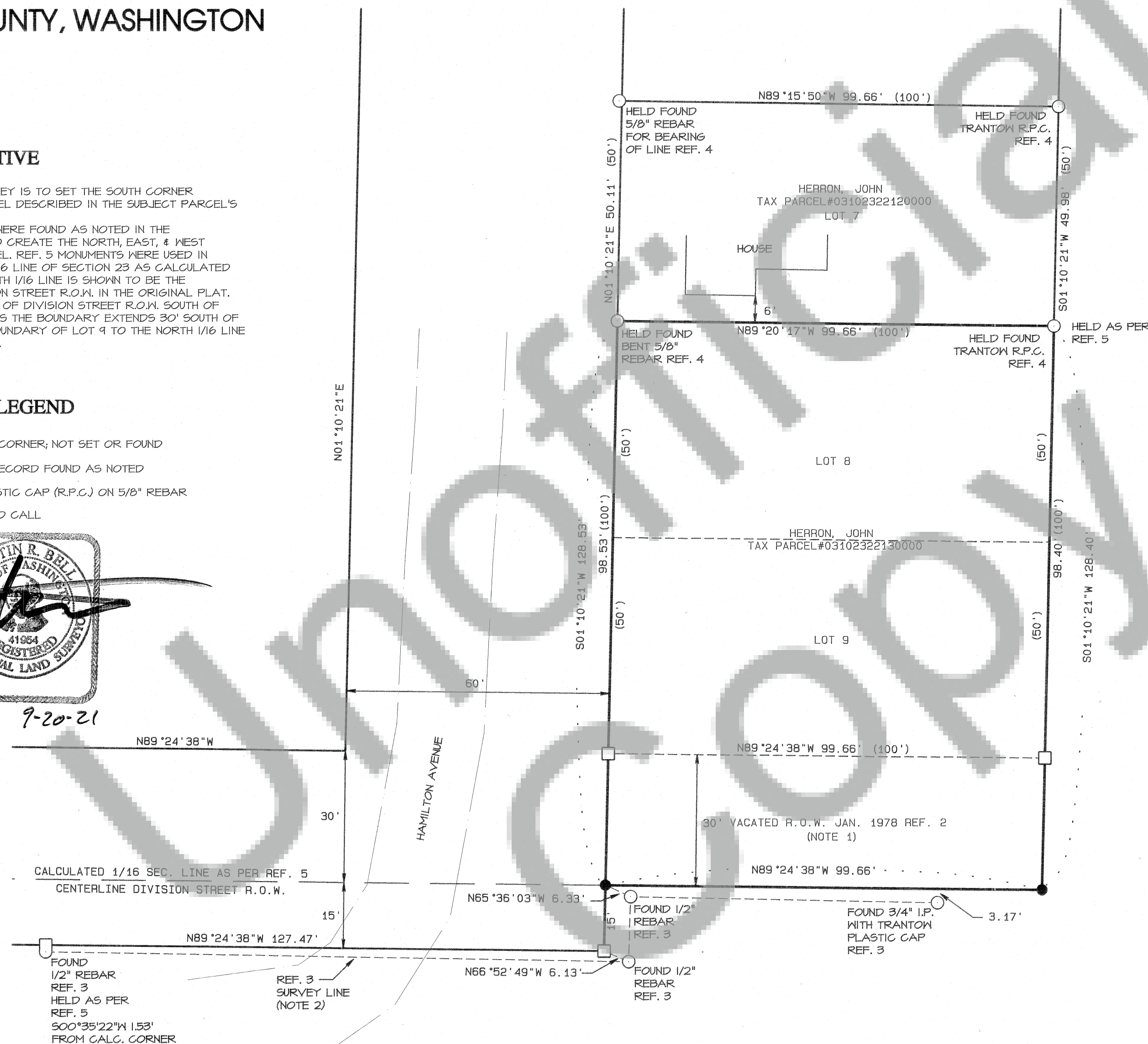
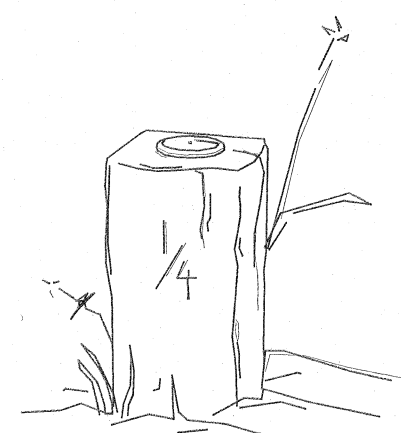
THE PURPOSE OF THIS SURVEY IS TO SET THE SOUTH CORNER MONUMENTS FOR THE PARCEL DESCRIBED IN THE SUBJECT PARCEL'S LEGAL DESCRIPTION. REFERENCE 4 MONUMENTS WERE FOUND AS NOTED IN THE SURVEY AND WERE USED TO CREATE THE NORTH, EAST, & WEST BOUNDARIES OF THE PARCEL. REF. 5 MONUMENTS WERE USED IN CALCULATING THE NORTH 1/16 LINE OF SECTION 23 AS CALCULATED IN REF. 5 SURVEY. THE NORTH 1/16 LINE IS SHOWN TO BE THE CENTERLINE OF THE DIVISION STREET R.O.W. IN THE ORIGINAL PLAT. REF. 2 SHOWS A VACATION OF DIVISION STREET R.O.W. SOUTH OF LOT 9 AS OF JAN. 1978. THUS THE BOUNDARY EXTENDS 30' SOUTH OF THE CALCULATED SOUTH BOUNDARY OF LOT 9 TO THE NORTH 1/16 LINE OF SECTION 23. SEE NOTE 1.

LEGAL DESCRIPTION

NOTES

- 1) AS PER WAC 50.17.21, LANDOWNERS OF PLATS RECEIVE THE LAND UNDER EASEMENT AND RIGHT OF WAYS THAT HAVE BEEN VACATED. THE 30' GRANTED FOR DIVISION STREET WAS AS PER PLAT OF HAMILTONS (REF. 1) AND VACATED AS PER AMENDED PLAT (REF. 2). THUS LOT 9 RECEIVES THE FULL 30' OF SAID 1970 VACATION.
- 2) THE REF. 3 SURVEY BY TRANTON ATTEMPTED TO CREATE THE NORTH 1/16 LINE OF SECTION 23 WHICH IS THE NORTH LINE OF THE TOWN OF UNDERWOOD. HOWEVER, THE SET REF. 3 MONUMENTS WERE IGNORED WHEN HE DID THE REF. 4 SURVEY.

TRAVERSE & ACCURACY STATEMENT

TIES TO CONTROLLING MONUMENTS WERE MADE WITH A TRIMBLE 55 FIVE-SECOND TOTAL STATION AND RELATED MEASURING EQUIPMENT, OF WHICH MEET STATE STANDARDS (WAC 332-130-090,100) AT THE TIME OF THIS SURVEY.

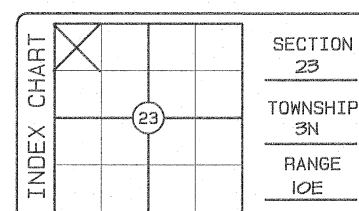
