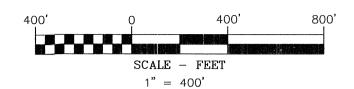
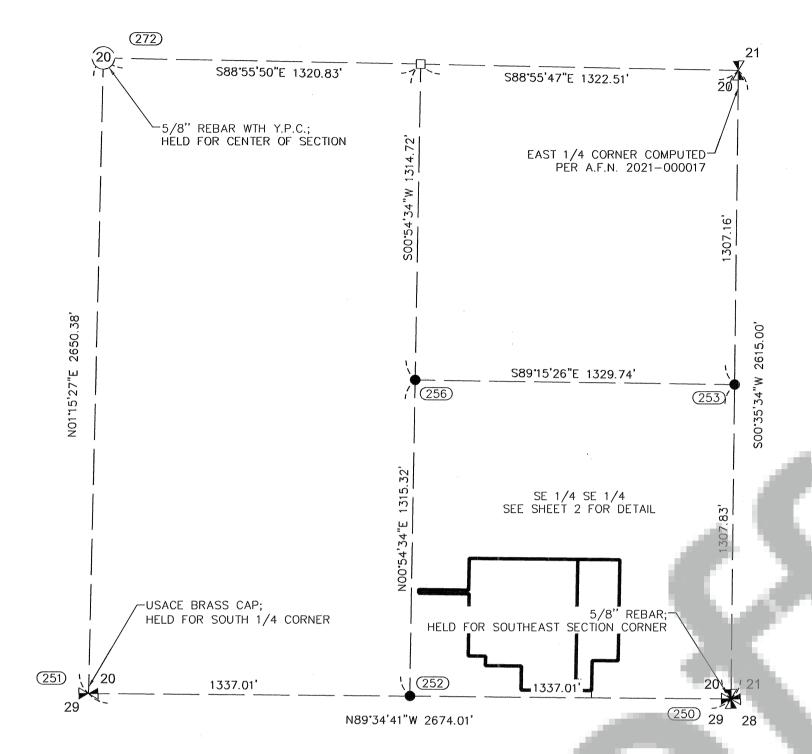

NOTES:

A. ALL ROADS EASEMENTS SHOWN ARE PRIVATE ROAD EASEMENTS FOR INGRESS, EGRESS, AND PUBLIC UTILITIES.

B. LAND WITHIN THIS SHORT PLAT SUBDIVISION SHALL NOT BE FURTHER SUBDIVIDED FOR A PERIOD OF 5 YEARS UNLESS A FINAL (LONG) PLAT IS FILED PURSUANT TO SKAMANIA COUNTY CODE, TITLE 17 SUBDIVISION, CHAPTER 17.04 THROUGH 17.60 INCLUSIVE.

C. "WARNING" PURCHASERS OF A LOT, OR LOTS, IN THIS SHORT PLAT ARE ADVISED THAT THE LOT, OR LOTS, IN THIS SHORT PLAT ARE SERVICED BY PRIVATE ROADS. PRIVATE ROADS ARE NOT MAINTAINED BY SKAMANIA COUNTY. LOT OWNERS WITHIN THIS SHORT PLAT MUST PAY FOR THE MAINTENANCE OF THE PRIVATE ROADS SERVING THIS SHORT PLAT, INCLUDING GRADING, DRAINAGE, SNOW PLOWING, ETC. THE CONDITIONS OF THE PRIVATE ROAD MAY AFFECT SUBSEQUENT ATTEMPTS TO DIVIDE YOUR LOT OR LOTS. PRIVATE ROADS MUST COMPLY WITH SKAMANIA COUNTY PRIVATE ROAD REQUIREMENTS. ("ORD. 2004–01 (PART)) AS REQUIRED UNDER SKAMANIA COUNTY CODE, 17.64.080 — MAP REQUIREMENTS.

D. ALL NEW DRIVEWAYS AND APPROACHES SHALL MEET THE STANDARDS IN SKAMANIA COUNTY PRIVATE ROAD MANUAL.

E. NOTICE: THE OHNEMUS SHORT PLAT LIES IN A VERY HIGH-RISK AREA OF ARCHAEOLOGICAL SIGNIFICANCE. IN THE EVENT OF INADVERTENT DISCOVERY OF POTENTIALLY SIGNIFICANT ARCHAEOLOGICAL MATERIALS (BONES, SHELL, STONE TOLLS, HEARTHS, ECT.) AND/OR HUMAN REMAINS DURING CONSTRUCTION ACTIVITIES, ALL WORK IN THE IMMEDIATE AREA SHALL CEASE, THE AREA SECURED, AND THE DISCOVERY SHALL BE REPORTED TO WASHINGTON STATE DEPARTMENT OF ARCHAEOLOGY AND HISTORIC PRESERVATION (DAHP) AND ALL RELEVANT ENFORCEMENT, THE COUNTY MEDICAL EXAMINER, STATE PHYSICAL ANTHROPOLOGIST AT DAHP, ALL RELEVANT NATIVE AMERICAN TRIBES AND THE COMMUNITY DEVELOPMENT DEPARTMENT SHALL BE CONTACTED IMMEDIATELY

F. EACH OF THE LOTS WITHIN THE OHNEMUS SHORT PLAT MEETS THE MINIMUM ACCEPTABLE STANDARDS FOR SITING SEWAGE DISPOSAL SYSTEM IN THE REFERENCED TEST PIT LOCATIONS. ANY CHANGES TO THE SITE AND/OR CONDITIONS OF APPROVAL MAY VOID THIS EVALUATION AND APPROVAL. A SATISFACTORY SITE EVALUATION DOES NOT CONSTITUTE AN INDEFINITE APPROVAL FOR SEWAGE DISPOSAL SYSTEM.

G. THE APPROVED INITIAL, RESERVE, AND/OR EXISTING SEWAGE SYSTEM SITES ON SHALL BE PROTECTED FROM DAMAGE DUE TO DEVELOPMENT. THESE SITES SHALL BE MAINTAINED SO THEY ARE FREE FROM ENCROACHMENT BY BUILDINGS, ROADS, AND OTHER STRUCTURES. THESE AREAS SHALL NOT BE COVERED BY ANY IMPERVIOUS MATERIAL AND NOT BE SUBJECT TO VEHICULAR TRAFFIC OR OTHER ACTIVITY WHICH WOULD ADVERSELY AFFECT THE SOIL.

H. EACH LOT HAS BEEN APPROVED FOR CONNECTION TO THE SKAMANIA COUNTY PUD CARSON GROUP A PUBLIC WATER SYSTEM AND PUBLIC WATER HAS BEEN PROVIDED TO EACH LOT.

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO SHORT PLAT THE TRACT OF LAND DESCRIBED IN STATUTORY WARRANTY DEED, BOOK 187, PAGE 732 INTO TWO LOTS AS SHOWN.

THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 20 WAS BROKEN DOWN AS IT WAS IN A.F.N. 2021-000017, AND AS SHOWN ON THIS SURVEY. IT SHOULD BE NOTED THAT BRASS CAPS WERE RECOVERED AT THE SOUTHWEST, NORTHWEST, AND NORTHEAST CORNER OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4, BUT THEY WERE NOT HELD. ALTHOUGH THEY WERE NOT HELD, THEIR DEPARTURE FROM COMPUTED POSITIONS WERE IN AGREEMENT WITH A.F.N. 2021-000017 AS WELL AS BOOK 2, PAGE 69 OF SURVEYS. DEED DISTANCES FROM STATUTORY WARRANTY DEED BOOK 187, PAGE 732 WERE USED IN COMBINATION WITH THE BEARINGS ESTABLISHED ON THE SOUTH AND WEST LINES OF SAID SOUTHEAST 1/4 OF SOUTHEAST 1/4 TO ESTABLISH THE BOUNDARY LINES WHERE NO MONUMENTS WERE FOUND. MONUMENTS FROM R.O.S BOOK 2, PAGE 69 WERE FOUND AND HELD IN THE NORTHWEST CORNER OF THE PROPERTY (MONUMENTS 257, 260, AND 261,) AND REBARS OF UNKNOWN ORIGIN WERE ALSO HELD (MONUMENTS 263, 265, 271.)

IT SHOULD BE NOTED THAT AN AMBIGUITY EXISTS IN THE PORTION OF THE DEED EXCEPTING OUT TAX LOT 1900. THE POINT OF BEGINNING CALLS FOR THE SOUTHEAST CORNER OF THE MCNEIL TRACT AS RECORDED IN BOOK "T", PAGE 578 OF SKAMANIA COUNTY DEED RECORDS, SAID POINT ALSO BEING 455 FEET WEST AND 30 FEET NORTH OF THE SOUTHEAST CORNER OF SECTION 20. THE POINT WE COMPUTED FOR THE SOUTHEAST CORNER OF THE MCNEIL TRACT WAS ACTUALLY 471.57' FEET WEST OF THE FOUND SOUTHEAST CORNER OF SECTION 20. WE HELD THE CALL FOR THE POINT BEING 455 FEET EAST AND 30 FEET NORTH OF THE CORNER AS THAT DISTANCE MATCHED WITH EXISTING LINES OF POSSESSION

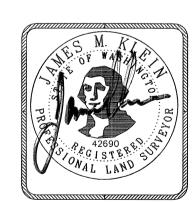
