9. For Plaintiff's reasonable attorneys' fees as provided for under RCW 4.84 in the sum of \$200.00.

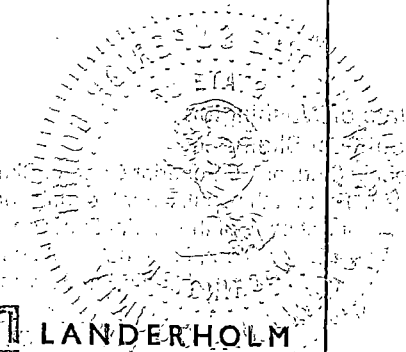

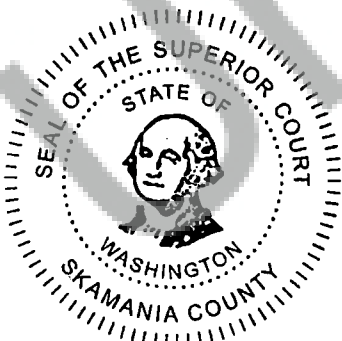
