THESE BOUNDARIES HAVE BEEN SURVEYED BY TERRA IN 2018. WE RÉCOVERED MONUMENTS FROM SKAMANIA COUNTY RECORD OF SURVEY, AUDITOR'S FILE No. 2008171545, WERE FOUND AND HELD FOR THIS BOUNDARY SURVEY. THE AFOREMENTIONED SURVEY HELD THE ALUMINUM CAP AT THE NORTHEAST CORNER OF SECTION 15 AS OPPOSED TO THE SKAMANIA COUNTY BRASS CAP TO THE NORTHEAST OF IT. RESEARCHING OTHER SURVEYS OF RECORD, SHOW THAT THE ALUMINUM CAP WAS HELD AS THE EAST LINE OF SECTION 15 IN LANDS LYING IN SECTION 15, WHILE THE SKAMANIA COUNTY BRASS CAP WAS HELD AS THE WEST LINE OF SECTION 14 FOR LANDS LYING IN SECTION 14. THE LARGER PORTION OF TAX PARCEL 04071500011000 WAS CALCULATED FROM SURVEY BOOK 3, PAGE 397 IN SKAMANIA COUNTY RECORDS, WHICH ALSO DEFINES AND MONUMENTED THE NORTH RIGHT OF


