

6 satisfy, and discharge the balance of the judgment.

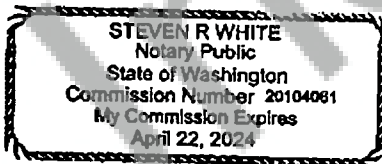

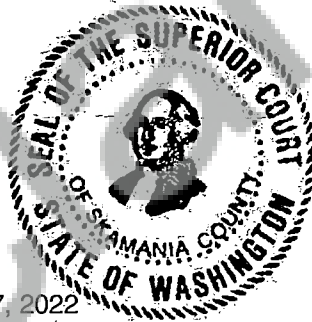
