## NARRATIVE:

THE PURPOSE OF THIS SURVEY WAS TO ADJUST THE PROPERTY LINES OF OUR CLIENT'S PROPERTY TO BE THE NORTH RIGHT OF WAY LINE OF MONTELL TERRACE EXTENSION. THE PROPERTY IS DESCRIBED ON AFN#2005158952, BEING ALL THAT PORTION OF GOVERNMENT LOT 5 AND LOT 8 OF SECTION 36 WITH THE FOLLOWING EXCEPTIONS: 1) SOUTH OF THE AMENDED PLAT HILLTOP MANOR (BOOK A, PAGE 110) 2) ALL THAT PORTION LYING WITHIN AND SOUTHERLY OF COUNTY ROAD NO.2385, DESIGNATED AS EL PASO LANE (BOOK 61, PAGE 759) AND PUBLIC ROAD DESIGNATED AS MONTELL TERRACE EXTENSION AND MONTELL TERRACE AND ALSO INCLUDING A STRIP OF LAND LYING WESTERLY OF THE WEST BOUNDARY OF HILLTOP MANOR, EXTENDING SOUTH TO STRAWBERRY ROAD. IN THE FIELD, WE TIED INTO RECORD MONUMENTS DEFINING SAID EXCEPTIONS. THE EAST LINE OF GOVERNMENT LOT 5 WAS CALCULATED BY TYING INTO 5/8" IRON RODS, L.S.18731 (BOOK 2, PAGE 287) OF SURVEYS. THE NORTH LINE OF THE AMENDED HILLTOP MANOR WAS CALCULATED BY TYING INTO MONUMENTS DEFINING THE SOUTH LINE OF RIDGECREST DRIVE, THIS LINE WAS OFFSET 50 TO THE NORTH TO POSITION THE SOUTH LINE OF THE SUBJECT PROPERTY. THE LOCATION OF GEOMETRY FOR MONTELL TERRACE WAS CALCULATED FROM THE SHORT PLAT FOR MCEVOY (BOOK T, PAGE 6). THE NORTH LINE OF GOVERNMENT LOT 5 WAS PLACED BY HOLDING TWO IRON RODS FROM BOOK 2, PAGE 287. ONE AT THE NORTHEAST CORNER OF THE SUBJECT AND ONE AT THE SOUTHWEST CORNER OF THE SUBJECT. I HELD RECORD DISTANCES FROM SOUTH AND EAST TO PLACE THE NORTHWEST CORNER OF GOVERNMENT LOT 5.

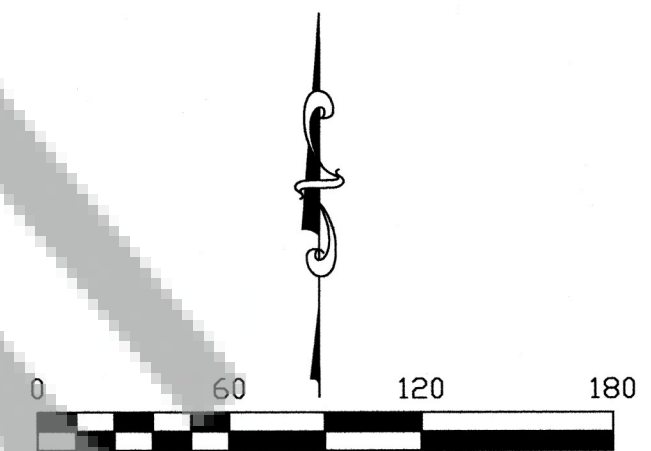
