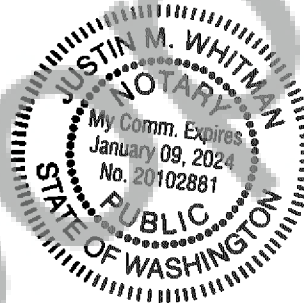

A TRACT OF LAND LOCATED IN THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 36, TOWNSHIP 3 NORTH, RANGE 7 EAST OF THE WILLAMETTE MERIDIAN, IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT MARKED BY AN IRON BAR ON THE WESTERLY RIGHT OF WAY LINE OF THE COUNTY ROAD KNOWN AND DESIGNATED AS MAPLE WAY ROAD, SAID POINT BEING 750.30 FEET NORTH AND 701.16 FEET WEST FROM THE CENTER OF SAID SECTION 36; THENCE SOUTH ALONG THE WESTERLY RIGHT OF WAY LINE OF SAID ROAD 25 FEET; THENCE WEST 129 FEET; THENCE NORTH 225 FEET; THENCE EAST TO THE WESTERLY RIGHT OF WAY LINE OF MAPLE WAY ROAD; THENCE SOUTHERLY FOLLOWING SAID WESTERLY RIGHT OF WAY LINE TO THE POINT OF BEGINNING.
