RELEASE AND RELINQUISHMENT OF EASEMENT

This Release and Relinquishment of Easement ("Agreement") is dated the _____ day of May, 2022 and entered by and between Port of Skamania County, a Washington municipal corporation ("Port") and Wilder & Pine Riverside Cabins, LLC, a Delaware limited liability company ("W&P"), each a "Party" and together the "Parties."

RECITALS

- A. Port owns the real estate legally described on the attached **Exhibit A** and referred to individually in this Agreement as the "**Port Property**".
- B. W&P owns the real estate legally described on the attached **Exhibit B** and referred to individually in this Agreement as the "W&P Property".
- C. The W&P Property is benefited by a non-exclusive easement for egress only, described as a 5 foot easement for ingress and egress running along the East line of Lot B as described in Exchange Agreement recorded under Auditor's File No. 119426 under Book 143 Page 134, dated May 16, 1994 ("Egress Easement"), subject to conditions, including but not limited to that W&P shall design, plan, and construct a well-graded, properly drained and graveled roadway, approximately 12 feet in width, at its sole expense, which roadway shall be available for use by the public in general. The Egress Easement was granted or reserved by a deed recorded on May 16, 1994, under Auditor's File No. 119428 under Book 143 Page 142 ("Deed").
- D. By entering into this Agreement, the Parties intend to release and relinquish the Egress Easement including all rights associated specifically with the Egress Easement.
