

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO CONFIRM THE LOCATION OF CENTERLINE MONUMENTS RECOVERED ALONG FRANK JOHNS ROAD. WHICH COULD HAVE BEEN SUBJECT TO REMOVAL OR DISTURBANCE DUE TO THE CONSTRUCTION OF SANITARY SEWER IMPROVEMENTS, AS SHOWN ON THE FACE OF THIS SURVEY. ONE MONUMENT LOCATED AT THE INTERSECTION OF FRANK JOHNS ROAD AND LOOP ROAD, WAS FOUND TO BE WITHIN ACCEPTABLE TOLERANCE OF THE PREVIOUS TIED POSITION AND HELD IN THIS SURVEY. TWO OTHER CENTERLINE MONUMENTS ALONG FRANKS JOHNS ROAD WERE REMOVED DURING CONSTRUCTION ACTIVITIES AND REPLACED WITH A 5/8" REBAR WITH 2" ALUMINUM CAP AND SET WITHIN A MONUMENT CASE AND THE PREVIOUSLY TIED POSITION. NO RESEARCH WAS PERFORMED ON ROAD ALIGNMENTS AND RIGHT=OF-WAY WIDTH. ROAD INFORMATION SHOWN IN THIS SURVEY IS FOR GRAPHIC PURPOSES ONLY.

THE BASIS OF BEARING FOR THIS SURVEY IS THE WASHINNGTON COORDINATE SYSTEM OF 1983, SOUTH ZONE, BASED ON STATIC GPS OBSERVATION ON POINTS NO. 112, AND PROCESSED THROUGH THE NATIONAL GEODETIC SURVEY (NGS) ONLINE POSITIONING USER SERVICE (OPUS).

LOCAL PROJECT COORDINATES ARE BASED ON THE PUBLISHED NGS OPUS—RS SOLUTION REPORT, NAD 83 (2011)(EPOCH 2010.0), UTILIZING THE NATIONAL GEODETIC SURVEY (NGS) ONLINE POSITIONING USER SERVICES (OPUS) SOFTWARE PROGRAM. TO COVERT THE LOCAL PROJECT COORDINATES TO WASHINGTON COORDINATE SYSTEM OF 1983, SOUTH ZONE VALUES, MULTIPLY THE LOCAL PROJECT COORDINATES BY THE PROJECT COMBINED SCALE FACTOR OF 1.00002505 KLEIN & ASSOCIATES, INC. PERFORMED A DILIGENT SEARCH FOR ALL MONUMENTS OF RECORD WITHIN THE CONSTRUCTION LIMITS OF THE SANITARY SEWER IMPROVEMENT PROJECT. ALL RECOVERED MONUMENTS SHOWN HEREIN WERE VISITED AND MEASURED DURING THE COURSE OF THIS SURVEY ON APRIL 10, 2022, AND RETIED OR SET ON MAY 16, 2022.

PROCEDURES

A STATIC GPS OBSERVATION WAS OBSERVED ON SURVEY CONTROL POINT (112) AND PROCESSED THROUGH OPUS, ALONG WITH A CLOSED LOOP TRAVERSE, USING A 3" TRIMBLE TOTAL STATION. A LEAST SQUARE ADJUSTMENT WAS PERFORMED ON SAID CLOSED LOOP TRAVERSE, AND EACH CENTERLINE MONUMENT WAS TIED FROM MULTIPLE SURVEY CONTROL POINTS, AND ADJUSTED BY MEAN SUM.


