COMMUNITY PROPERTY SURVIVORSHIP AGREEMENT

This agreement may be terminated upon (1) the mutual agreement of the parties evidenced by any writing and (2) it shall be deemed terminated, revoked and of no further force or affect upon the death of the parties where the order of death can not in fact be ascertained without the aid of presumptions in law.
