## LOAN MODIFICATION AGREEMENT (Providing for Fixed Interest Rate)

In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

1. As of the Effective Date, the amount payable under the Note and the Security Instrument (the "Unpaid Principal Balance") is U.S. \$198,716.00, consisting of the unpaid amount(s) loaned to Borrower by Lender
