ASSIGNMENT AND ASSUMPTION AGREEMENT

This Assignment and Assumption Agreement ("Assignment") is entered into by and between ANE FORESTS OF LEWIS RIVER INC., a Washington corporation ("Assignor"), and RAYONIER FOREST RESOURCES, L.P., a Delaware limited partnership ("Assignee") and is effective as of January <u>24</u>, 2023 (the "Effective Date").

RECITALS

- A. Assignor and Assignee have entered into that certain Purchase and Sale Agreement, dated December 12, 2022 (the "Purchase Agreement"), pursuant to which, among other things, Assignor has agreed to sell to Assignee and Assignee has agreed to purchase from Assignor that certain real property located in Skamania County, Washington as more particularly described therein (the "Transaction").
- B. In connection with the Transaction, Assignor desires to assign to Assignee, and Assignee desires to accept from Assignor, an assignment of the Easements (as defined below) as more specifically set forth herein.

AGREEMENT

NOW, THEREFORE, in consideration of the mutual covenants and agreements of the parties herein contained and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. ASSIGNMENT. Assignor does hereby assign, transfer, set over, sell, convey, and deliver unto Assignee all of its present and future right, title, obligations and interest in and to the easements set forth on Exhibit "A" attached hereto and incorporated herein (the "Easements").
- 2. ASSUMPTION. Assignee does hereby expressly accept and assume Assignor's right, title, obligations and interest under the Easements.
- 3. INDEMNIFICATION: Assignor shall defend, indemnify, and hold Assignee, its officers, managers, employees, members, agents, and representatives free and harmless from and against any and all losses, damages, liabilities, claims, causes of action, and fees (including reasonable attorney's fees) arising from any obligation arising under or related to any of the Easements prior to the Effective Date. Assignee shall defend, indemnify, and hold Assignor, its officers, managers, employees, shareholders, directors, members, agents, and representatives free and harmless from and against any and all losses, damages, liabilities, claims, causes of action, and fees (including reasonable attorney's fees) arising from any obligation arising under or related to any of the Easements on and after the Effective Date.

4. OTHER.

- (b) This Assignment will be governed by, construed under and enforced in accordance with the laws of the State of Washington.

- (d) Each of the parties hereto shall execute and deliver, at the reasonable request of the other party hereto, such additional documents, instruments, conveyances and assurances and take such further actions as such other party may reasonably request to carry out the provisions hereof and give effect to the transactions contemplated by this Assignment.
