II. No action commenced by the Beneficiary of the Deed of Trust as referenced in RCW 61.21.030(4) is now pending to seek satisfaction of the obligation in any Court by reason of the Borrower's or Grantor's default on the obligation secured by the Deed of Trust/Mortgage.

III. The default(s) for which this foreclosure is made is/are as follows: Failure to pay when due the following amounts which are now in arrears: **\$44,401.56**.

IV. The sum owing on the obligation secured by the Deed of Trust is: The principal sum of **\$148,199.29**, together with interest as provided in the Note from **2/1/2020** on, and such other costs, fees, and charges as are due under the Note, Deed of Trust, or other instrument secured, and as are provided by statute.

Failure to bring such a lawsuit may result in a waiver of any proper grounds for invalidating the Trustee's sale.
