It is understood and agreed the Grantor is retaining ownership of all rights of ingress and egress, to, from and between the above referenced state highway route and/or Roadway Facilities and the properties abutting said state highway route and/or Roadway Facilities, including all rights of access, light, view and air, and access control as shown by the access prohibition symbol and as shaded on Exhibit A-2 to Turnback Agreement No. TB 4-0063 Amendment No. 2, dated November 3, 2022, along the above referenced state route and/or Roadway Facilities right of way and along abutting properties on the right of way access plans marked as Exhibit A-2. The Grantee, its successors or assigns, shall have no right of ingress or egress between the above referenced state route and abutting properties, or the state route and the lands herein conveyed that show the access prohibition symbol and as marked on Exhibit A-2. The Grantee, its successors or assigns, shall not be entitled to compensation for any loss of access, light, view, or air occasioned by the

The Grantee agrees to comply with, and require its successors or assigns to comply with, all civil rights and anti-discrimination requirements of Chapter 49.60 RCW, as to the right of way and Roadway Facilities herein conveyed.

The lands herein described are not required for State highway purposes and are conveyed pursuant to the provisions of RCW 36.75.090.
