The Lot Owner shall be subject to the following road use agreement All Lot Owners will share an equal cost in road maintenance including grading removal of snow and other hazards/obstructions, adding surface gravel and other necessary repairs to keep the Common Road (Haven Rd.) in good driving condition meeting county specifications.

Generally on an annual basis if 50% or more of the Lot Owners deem road maintenance is necessary then is shall be done by a competent person and the cost will be divided equally between Lot Owners Each lot shall have 1 vote, if a Lot Owner does not vote they will still be responsible for their portion of costs if a yes vote is greater than 50% and the costs are incurred.

New Individual driveways connecting the lots to the Common Roads may require a culvert as to not block ditches. New roads should be built as to minimize and prevent water or dirt to be tracked out onto the existing road system. Individual lots access roads are to be kept in repair by the lots owner and damages caused to the Common Road by specific driveway access will be fixed by the Lot Owner.
