

History:

(1987)- Visited by Terry Trantow (WA PLS#15673) of T.N. Trantow Surveying in April 1987. Recorded in book 3 of short plats page 128 with an auditor file #104459 in Skamania County. An LCR was also recorded in Book 4 of 9, page 71, file number 103457. Reported finding a 2" iron pipe Northeasterly of determined corner position. "Pipe was apparently referenced by penciled metal tags circa mid-1940's. Subsequent investigation into Broughton Lumber Company records revealed no indication of this pipe. The pipe was not accepted for position, used for reference only."

Set a 1-1/4"x30" galvanized iron pipe with 2-1/2" brass cap set 20" in the ground, in a cluster of stones by single proportion between the original SE and SW corners of section 22. The following references were described:

- 2" iron pipe, bears N 24° E, 29.34' distance.
- 24" Cut Fir Stump, bears N 36° W, 9.55' distance to center of stump.
- 24" Cut Fir Stump, bears S 85° E, 8.90' distance to center of stump.

Both stumps marked with aluminum witness tags. Corner falls near the bottom of main draw, on a small ridge North of channel. Area was clearcut approximately 1975.

(1988)- Field work preformed September 1988, Frederick L. Martin (WA PLS#10785) of Lee and Martin Surveying under USDA Forest Service contract during the Lava Thin Cadastral Survey recorded in book 3 of survey Page 5, auditor file number 106496 with Skamania County in 1989. An LCR was also filed in Book 4-9, Page 129, file number 106518. The following bearing trees and corner evidence were described:

Found 1-1/4" iron pipe with 2-1/2" brass cap, 1' above the ground painted red and marked.

- R.P. 24" Douglas Fir Stump, bears N 36° W, 9.55' distance to center of stump.
- R.P. 24" Douglas Fir Stump, bears S 85° E, 8.90' distance to center of stump.
- R.P. 2" Iron Pipe 12" above the ground, bears N 23° E, 31.00' distance.

Set orange plastic post with 54-9 sign attached 4' N & 4' E of corner.

Evidence:

(2023)- R. Ellis of USDA Forest Service, Columbia Lands Zone on 5/18/2023 recovered the E 1/16 corner monument to S22 & S27 as set in 1987 by Trantow Surveying. 6" red bands were painted on all new bearing trees. The following bearing objects were recovered:

- A 1-3/4" Iron Pipe, bears N 23° E, 31.00' distance, orange in color.
- A 24" Rotted Douglas Fir Stump, bears N 36° W, 9.55' distance, with 54-9 LSM sign attached.
- A 24" Rotted Fir Stump, bears S 85° E, 8.9' distance.

Corner lies on a gentle South facing slope leading into a small creek canyon.

Perpetuation:

New 12" Douglas Fir, Bears S 75° W, 15.90' distance, scribed "E1/16S27BT" with 54-9 LSM sign on the back and 54-3 BT tag attached to the tree above the scribe blaze, 2.5" PK Nail with 2" diameter brass washer marked WA PLS#20100531 set right side center from monument 8.5" above the ground.

Set 2 aluminum guard posts with 54-2 property boundary and 54-9 Land Survey Monument signs 5' North and 5' East of monument.
