NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO ESTABLISH THE BOUNDARIES OF LOTS 5, 6, 7, AND 8 OF BLOCK 1 TOGETHER WITH LOTS 2, 3, 4 AND 5 OF BLOCK 2, COLUMBIA VIEW ADDITION. WITH THE EXCEPTION OF THE RESIDENCE ON LOT 3, BLOCK 2 THE LOTS HAVE REMAINED UNDEVELOPED SINCE THEIR PLATTING IN 1949. JEFFERSON STREET AND COLUMBIA DRIVE ALSO REMAIN UNDEVELOPED. I HELD FOUND MONUMENTS AND RECORD DATA FROM SURVEY REFERENCES 2 AND 6 TO ESTABLISH THE EXTERIOR BOUNDARIES OF THE PLAT. TO ESTABLISH THE LOTS, I HELD PLAT DATA AS MUCH AS POSSIBLE. ANY EXCESS OR DEFICIENCY WAS PLACED IN THE NORTH AND EAST SUBDIVISION LINES AS THIS SEEMS TO BE THE INTENT OF THE PLAT. THE WEST LINE OF THE SUBDIVISION IS DEFINED BY THE BROW OF ROCK CREEK CANYON. I FOUND NUMEROUS IRON PIPES WESTERLY AND SOMEWHAT NORTHERLY OF MY CALCULATED LOT CORNER POSITIONS. I NEEDED TO EVALUATE IF THESE PIPES WERE ORIGINAL PLAT MONUMENTS. THE PLAT DOES NOT MENTION WHAT MONUMENTS, IF ANY, HAD BEEN SET. AN ADJOINING NEIGHBOR STATED THAT HE HAD BEEN TOLD THAT THE PREVIOUS OWNERS OF THE SUBJECT LOTS HAD A SURVEY DONE AT LEAST 20 YEARS AGO FOR THE PURPOSE OF SELLING SOME OF THE LOTS. MY EVALUATION IS THAT THERE WAS A SURVEY DONE NOT IN COMPLIANCE WITH THE SURVEY RECORDING ACT BY SOME UNKNOWN INDIVIDUAL. FALLINGS FROM THE CALCULATED LOT CORNER POSITIONS TO THE FOUND IRON PIPES ARE SHOWN BELOW.

MONUMENT FALLINGS

EQUIPMENT USED, METHOD OF SURVEY AND ACCURACY

A CLOSED LOOP TRAVERSE WAS RAN USING A GEOMAX 3" ROBOTIC TOTAL STATION AND RELATED EQUIPMENT. SEVERAL SPURS WERE RAN FROM THE CLOSED LOOP FOR ADDITIONAL TIES. DIRECT AND REVERSE MEASUREMENTS OF ANGLE AND DISTANCE WERE MADE TO THE FOUND MONUMENTS. THE TRAVERSE WAS ADJUSTED BY LEAST SQUARES USING STAR*NET SOFTWARE. POSITIONAL TOLERANCE OF 0.07 FEET +/- 200 PPM AT THE 95% CONFIDENCE LEVEL WAS PASSED AS ESTABLISHED BY WAC 332-130-085.
