

Kapp and Ora Lee Kapp Revocable Living Trust dated August 30, 2006 (the "Kapp Disclaimer Trust"), as to an undivided one-half (½) interest as a tenant-in-common, the Grantor's entire interest, including any after-acquired interest, in and to the real estate situated in Skamania County, Washington, described as follows:

KAPP, and pursuant to the terms of the governing instrument of the Kapp Family Trust, HENRY D. KAPP became the sole Trustee of the Kapp Family Trust and all subtrusts established under its governing instrument.

Upon her death, and pursuant to the terms of the governing instrument of the Kapp Family Trust, ORA LEE KAPP'S undivided one-half interest in the assets of the Kapp Family Trust became distributable to DAVID H. KAPP. On December 8, 2023, and December 22, 2023, HENRY D. KAPP, as the sole Trustee of the Kapp Family Trust, executed sequential instruments disclaiming certain portions of DAVID H. KAPP'S interest in ORA LEE KAPP'S share of the assets of the Kapp Family Trust, and as a result of those disclaimers, the Kapp Disclaimer Trust provided for under the terms of the Kapp Family Trust's governing instrument of the was established.

The liability and obligations of the Grantor to Grantee and the Grantee's successors under the warranties contained herein shall be limited to the amount, nature and terms of any title insurance coverage available to the Grantor under any title insurance policy. The Grantor shall have no liability or obligations except to the extent that reimbursement for such liability or obligation is available to the Grantor under any title insurance policy.
