THIS EASEMENT AMENDMENT is made by and between JOHN K. ZIEGLER AND DENISE J. ZIEGLER, HUSBAND AND WIFE AND THOMAS W. KELLER, AN UNMARRIED MAN (hereafter "Exchanger") and STATE OF WASHINGTON, acting by and through the Department of Natural Resources (hereafter "State"), (collectively referred to as "Parties").

### RECITALS

On the 6<sup>th</sup> of June 1962, Swanberg Bros. Milling Co. granted State an un-related easement agreement which was recorded in the Auditor's Office of Skamania County, Washington on July 24, 1962, under Auditor File No. 66258 and filed in the

- B. WHEREAS, On the 6th of March 1989, Orville Esteb and State entered into an easement exchange agreement which was recorded in the records of Skamania County, Washington on April 3, 1989 under Auditor File No. 106796 and filed in the Washington State Office of the Commissioner of Public Lands, in Olympia Washington under file numbers ("50-049841" and "55-002303"), hereafter "Original Easement"; AND,
- C. WHEREAS, John Ziegler and Tom Keller are successors in interest to Swanberg Bros. Milling Co. and Orville Esteb; AND,
- D. WHEREAS, The Parties intends to amend the Original Easement to provide for additional access roads to benefit both Parties lands ("Amendment"); AND,
- E. WHEREAS, The Exchanger intends to release portions of the Original Easement; AND,
- F. WHEREAS, The Parties intends to replace Exhibit A of the Original Easement; AND,
- G. WHEREAS. The Parties intends to add Exhibit B to the Original Easement; AND,
- H. WHEREAS, State intends to add Habitat Conservation Plan clauses to the Original Easement, which only burdens the States land.

State for and in consideration of the grant hereinabove made, hereby grants and conveys to Esteb, his successors and assigns, a permanent easement upon, over and along rights or way sixty (60) feet in width, over and across the SE1/4 NW1/4, E1/2SW1/4, Section 10, and the N1/2 NE1/4, Section 15, Township 3 North, Range 6 East, W.M. in Skamania County, Washington, being thirty (30) feet on each side of the centerlines of a road or roads located approximately as shown in green on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

Esteb for and in consideration of the grant hereinafter made by State, hereby grants and conveys to State, its successors and assigns, a permanent easement upon, over and along rights or way sixty (60) feet in width, over and across the SW1/4 NE1/4, SE1/4SE1/4, W1/2SE1/4, Section 10, Township 3 North, Range 6 East, W.M. in Skamania County, Washington, being thirty (30) feet on each side of the centerlines of a road or roads located approximately as shown as "STATE EASEMENT AREA" on the attached "Exhibit A", and more specifically shown on that Center Line Survey, recorded February 26, 2025, in Skamania County under Auditor File Number 2025-000277, and by this reference made a part hereof.

Subject as to said lands to all matters of public record.

B. State for and in consideration of the grant hereinabove made, hereby grants and conveys to Esteb, his successors and assigns, a permanent easement upon, over and along rights or way sixty (60) feet in width, over and across the SE1/4 NW1/4, E1/2SW1/4, Section 10, and the N1/2 NE1/4, Section 15, Township 3 North, Range 6 East, W.M. in Skamania County, Washington, being thirty (30) feet on each side of the centerlines of a road or roads located approximately as shown as "EXCHANGER EASEMENT AREA" on the attached "Exhibit A", and more specifically shown on that Center Line Survey, recorded February 26, 2025, in Skamania County under Auditor File Number 2025-000277, and by this reference made a part hereof.

Subject as to said lands to all matters of public record.

Exchanger also releases easement over that portion of road as shown as "EXCHANGER EASEMENT RELINQUISHMENT" on "Exhibit A"

State also wishes to add the following Clauses to the Original Easement:

Compliance with Habitat Conservation Plan. The Proposed Exchanger Easement Area is located within an area that is subject to the State's Habitat Conservation Plan adopted in connection with Incidental Take Permit No. TE812521-1 as supplemented by Permit No. 1168 (collectively "ITP"). As long as the Habitat Conservation Plan remains in effect, Grantee and all contractors, subcontractors, invitees, agents, employees, licensees or permittees acting under Grantee shall comply with the terms and conditions set forth in Exhibit B while operating on the Easement Area.

All exhibits referenced in the Amendment are incorporated as part of the Amendment and will only reflect changes resulting from this Amendment.

Except as amended hereby, the THIS AGREEMENT shall remain in full force and effect as previously executed, and the Parties ratify the THIS AGREEMENT as amended. The Amendment is limited as specified herein and shall not constitute a modification, acceptance or waiver of any other provision of the THIS AGREEMENT. From and after the date hereof, all references to the THIS AGREEMENT shall be deemed references to the THIS AGREEMENT as amended.

The Amendment may be signed in counterparts, any one of which shall be deemed an original. Delivery by facsimile of an executed counterpart shall have the same effect as physical delivery of an original so long as the facsimile original is sent by overnight courier to the other party.

The Amendment requires the signature of the Parties and is effective on the date of the last signature below.





### **EXHIBIT B**

- 1) Exchanger shall immediately notify State of the following:
  - a) That Exchanger has discovered locations of any species listed by the U.S. Fish and Wildlife Service as threatened or endangered species (listed species) under the Endangered Species Act as such list may be updated from time to time; and
  - b) That Exchanger has located any live, dead, injured, or sick specimens of any listed species.
- 2) Notification required in subsection 1) must in all circumstances occur as soon as practicable but in any event within 24 hours.
- Exchanger may be required to take certain actions to help State safeguard the well-being of any live, injured or sick specimen of any listed species until the proper disposition of such specimen can be determined by State.
- 4) Any application for a Forest Practices Permit submitted by Exchanger for activities on the State Easement Area must identify that the State Easement Area is covered by the HCP.

### 5. TERMINATION:

- a. By Appointment of Guardian: The appointment of a guardian of the estate of the undersigned vests in the guardian with court approval, the power to revoke, suspend or terminate this Power of Attorney. The appointment of a guardian of the person does not empower the guardian to revoke, suspend or terminate this Power of Attorney.
- b. By Death of Undersigned: The death of the undersigned shall be deemed to revoke this Power of Attorney upon actual knowledge or actual notice being received by the agent.
