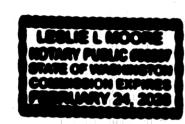

NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO DIVIDE PARCEL NO. 03082014040300 INTO TWO SEPARATE LOTS AS SHOWN. THE BOUNDARY IS DESCRIBED IN SUBDIVISION GUARANTEE, SCHEDULE "C", PREPARED BY COLUMBIA GEORGE TITLE COMPANY, GUARANTEE NO. 5003353-0009174E, FILE NO. S-24-444, DATED SEPT. 23, 2024.

THE SUBJECT PARCEL LIES WITH A PORTION OF LOT 2 OF THE PATRICIA GRUVER SHORT PLAT REVISED. RECORDED IN BOOK 2 OF SHORT PLAT PLAT PAGE 116. EXCEPTING THAT PORTION DESCRIBED IN QUIT CLAIM DEED - BOUNDARY LINE ADJUSTMENT, AUDITORS FILE NO. 2019000597.

THE NORTH LINE WAS ESTABLISHED BY HOLDING RECOVERING PROPERTY MONUMENT ALONG THE SOUTH LINE OF THE SHIELDS - REUST SHORT PLAT. THE WEST LINE WAS ESTABLISHED BY HOLDING EXISTING MONUMENTS RECOVERED ALONG THE WEST LINE OF THE PATRICIA GRUVER SHORT PLAT REVISED. THE EAST LINE WHICH IS BOUND BY METZGER ROAD, WAS COMPUTED BASED ON SAID SHIELDS - REUST SHORT PLAT. THE SOUTH LINE WAS ESTABLISHED BASE ON DEED ELEMTS FROM THAT QUIT CLAIM DEED - BOUNDARY LINE ADJUSTMENT, AUDITORS FILE NO. 201900059.

- C. THE SUBJECT PROPERTY LIES WITHIN A VERY HIGH-RISK AREA OF ARCHAEOLOGICAL SIGNIFICANCE.
