TRAVERSE & ACCURACY STATEMENT

DATA WAS COLLECTED USING A TRIMBLE R8 GNSS RECEIVER WITH RTK CORRECTIONS FROM THE WASHINGTON STATE REFERENCE NETWORK, UTILIZING REFERENCE BASE STATION (PRST50050405666). RADIAL MEASUREMENTS WERE MADE WITH A FIVE-SECOND TOTAL STATION AND RELATED MEASURING EQUIPMENT, OF WHICH MEET STATE STANDARDS (NAC 332-130-090,100) AT THE TIME OF THIS SURVEY.

RIGHT OF WAY NOTE

THE LEGAL DESCRIPTION FOR THE SUBJECT PARCEL CALLS THE CENTERLINE OF MABEE MINES ROAD AS THE BOUNDARY. REF. 3 SURVEYS A 30' EASEMENT ALONG THE SOUTH RIGHT OF WAY AND 20' ALONG THE NORTH SIDE FOR SAID ROAD. REF. 1 SHOWS A DASHED LINE WITH NO LABELS OR DIMENSIONS. RESEARCH OF THE COUNTY RECORDS SHOWS NO RIGHT OF WAY MAPS FOR MABEE MINES IN SECTION 35. THIS SURVEY DOES NOT SHOW ANY TITLED RIGHT OF WAY DISTANCE NORTH OF THE CENTERLINE. MONUMENTS WERE SET IN MABEE MINES ROAD SURFACE.

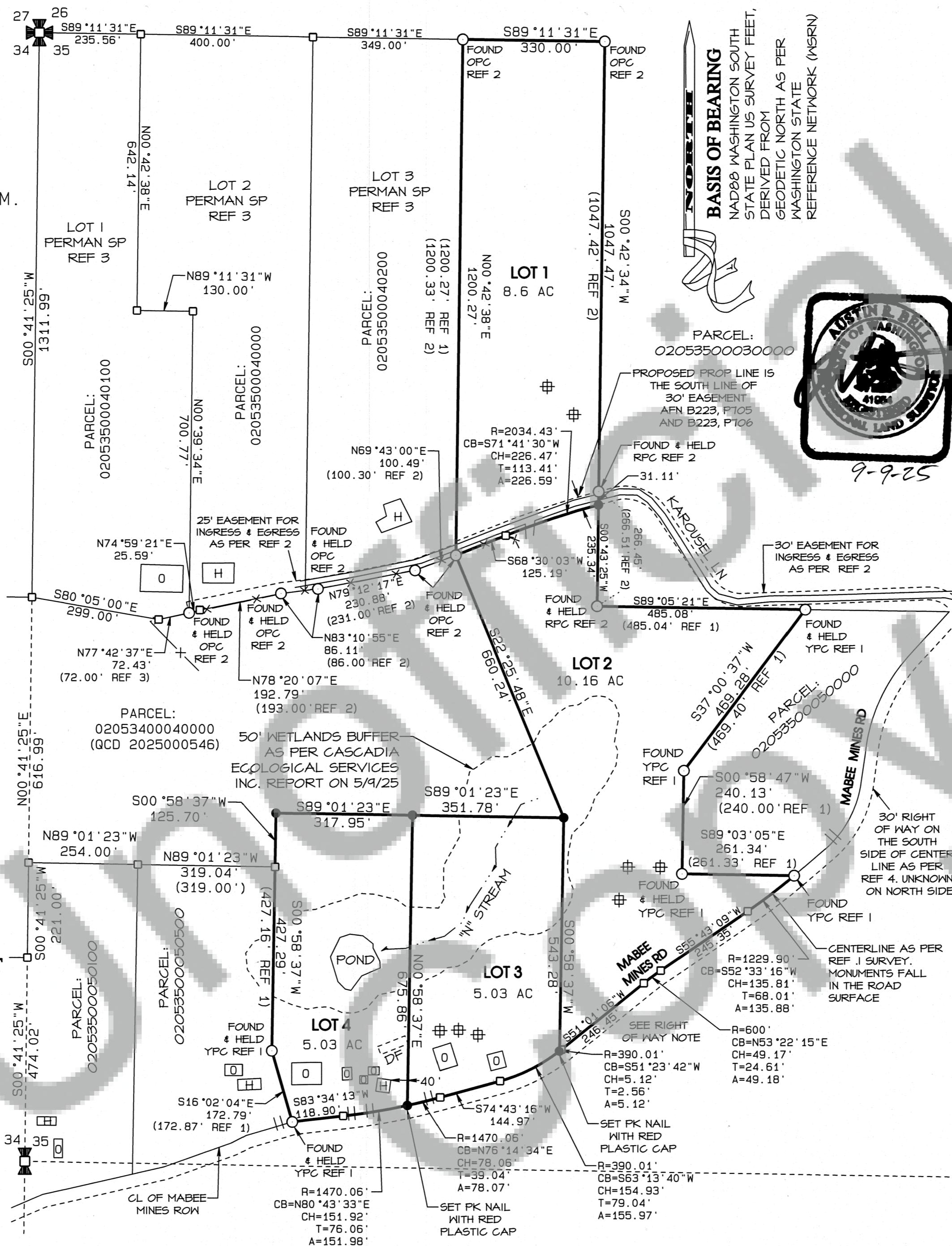

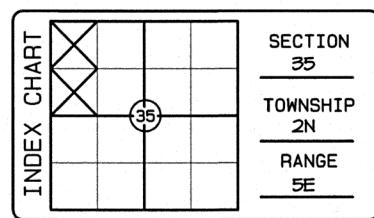
The approved initial, reserve, and/or existing sewage system sites shall be protected from damage due to development. These sites shall be maintained so they are free from encroachment by buildings, roads, and other structures. These areas shall not be covered by any impervious material and not be subject to vehicular traffic or other activity which would adversely affect the soil.

Each of the lots within the Woodland Short Plat meets the minimum acceptable standards for siting an onsite sewage disposal system in the referenced test pit locations. Any changes to the site and/or conditions of approval may void this evaluation and approval. A satisfactory site evaluation does not constitute an indefinite approval for a sewage disposal system.

A groundwater study compiled by a hydrologist, licensed in the state of Washington, concluded that based on analytical results, there is sufficient quantity and quality of water available to serve the lots in the Woodland Short Plat. However, no wells or other water sources have been constructed or approved within this short plat.

Land within this short subdivision shall not be further divided for a period of five years unless a final (long) plat is filed pursuant to Skamania County Code, Title 17, Subdivision, Chapter 17.04 through 17.60 inclusive.

Warning: Purchasers of a lot, or lots, in this short plat are advised that the lot, or lots, in this short plat are serviced by private roads. Private roads are not maintained by Skamania County. Lot owners within this short plat must pay for the maintenance of the private roads serving this short plat, including grading, drainage, snow plowing, etc. The condition of the private road may affect subsequent attempts to divide your lot, or lots. Private roads must comply with Skamania County's private road requirements.
