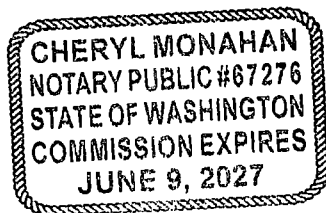

BEGINNING AT THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 3, TOWNSHIP 1 NORTH, RANGE 5 EAST OF THE WILLAMETTE MERIDIAN, SKAMNIA COUNTY, WASHINGTON, SAID POINT BEING THE NORTHEAST CORNER OF THAT TRACT OF LAND CONVEYED BY B. BENNETT TO EUNICE FROESCKLE AND THEREAFTER ACQUIRED BY J.J.
