There is no consideration for this Deed, and it is given solely for love and affection.

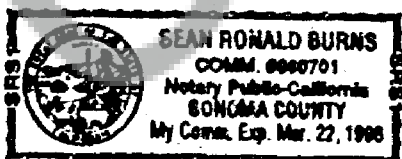

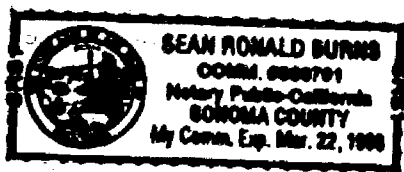
